



## FAR WEST U14 Spring Select March 22-24, 2024-Invite Only

- ENTRY:** \$150 for 3 days of Camp. Online event registration for all athletes, coaches, and officials please visit [adminskiracing.com](https://adminskiracing.com). All participants must hold a current Alpine Competitor membership with [US Ski and Snowboard](https://www.us-ski.org). All membership must be current no less than 24 hrs prior to registration. No on-site registration. No refunds or additions will be issued after the close of first TCM.
- ENTRY DEADLINE:** Registration for all entries closes Monday March 18, 2024, 11:59 PM. Registration can be found on [adminskiracing.com](https://adminskiracing.com). Athletes will have 72 hours to respond with registration once selections are open.
- LIFT TICKETS:** Athletes lift tickets: Child (6-12) \$39, Young Adult (13-22) \$64. Discounted Parent tickets for athletes on the start list are \$94. Tickets may be purchased at Judah Ticket Window.
- TEAM CAPTAINS' MEETING:** Day prior to event at 06:00 PM PST-Online Meeting Link and documentation will be sent ONLY to registered coaches and officials prior to event (ACR 604.3). All race communication will be posted on [Live-Timing](#) and [WhatsApp](#) (coaches only).
- ELIGIBILITY:** U14's by **INVITATION ONLY**. Current US Ski and Snowboard members from Far West and PNW.
- QUOTA:** The total quota will not exceed 68. Far West athletes (22 males and 22 females) plus 24 PNW athletes (based on their distribution rules). Quota distribution for the Far West U14's will be 44 athletes (California Challenge Series: 16 m/f, Central/ South: 6 m/f) selected from the continuation of the U14 Regional Championships Boards. The Central/South quota will be filled from their series races for SL and GS.
- SCHEDULE:** To be shared closer to the event date.
- RELEASE OF LIABILITY:** Sugar Bowl Resort requires a Release of Liability. Release of Liability must be completed on [adminskiracing.com](https://adminskiracing.com) in order to register for the event.
