#### **New Business:**

Claudia Yamamoto –

- 2024 PNW Convention slated for 1<sup>st</sup> weekend in June (1-2) and will be conducted over 2 days (Sat/Sun)
- Contract Labor budget line item explained: USSS has pulled funding from WR FIS to put toward USST development coaches. The plan is to hire another coach for WR FIS Elite special projects at the cost of \$72K. ½ of that salary will be paid by WR and the other ½ by divisions within based on quota. PNW portion would be 19% of \$36,000 or roughly \$6500-7000. Discussion of possible options to raising these funds:
  - ~raise head taxes on sanctioned/scored races
  - ~need to analyze head taxes on scored and sanctioned races first to determine this as a viable option
  - ~sanction YSL races as they are future FIS racers that would benefit
  - ~look to PNWSEF for some funding support
  - ~credit card rewards to cover some of commitment?

#### Rob Cravens –

2024/2025 Season will require that only Level 100 coaches be allowed in a race venue

- Rob opened discussion about filling out the Coaches Education Working Group so as to determine level 100 costs for training and provide incentives/assistance for coaches to attend training. 40 hour online portion/1 day on-hill training
- Need a directive from board to approach a funding source to reduce Level 100 costs
- Suggested Ben Roberts from MHA to help lead committee/Shana Sweitzer is current lead
- Discussion ended with Rob C's agreement to draft motions:
  - for a board directive to the PNW Alpine director to deliver Level 100 clinics to all PNW zones before year end. Alpine Director would also create a Taskforce/working group of committed individuals by deadline date of July 1, 2023. Noted that all existing committees should strive to fill out their respective working groups within this date deadline as well.
  - For a board directive to the PNW Alpine Director to provide oversight in designating up and coming leadership in the division for PNW Camps, Special Projects, Champs Events. To be initiated at the beginning of the 23-24 Season with continued identification of new leaders moving forward. Participation in Mentorship from present/previous leaders is crucial to development of new leaders.
